

Terms & Conditions

Mobile Photography Contest

1. Introduction

The Shoot for Pleasure Mobile Photography Contest (the "Contest") is open to all photographers. By participating in the Contest, each participant agrees to be bound by these Terms and Conditions.

2. Eligibility

The Contest is open to photographers of all ages. Participants must submit their original work, taken by themselves using a mobile phone, DSLR or Mirror less camera.

3. Categories

The Contest includes 13 categories for submission:

- 2. Landscape
- 3. Street Photography
- 4. Wildlife
- 5. Sports
- 6. Fashion
- 7. Food
- 8. Travel
- 9. Documentary
- 10. Night Photography

4. Submission Guidelines

- Participants must submit their photographs in digital format (JPEG).
- Each participant can submit up to 1 photograph per category, Maximum 3 categories allowed.
- Photos must be taken using a mobile phone, DSLR or Mirror less camera.
- Photos must be original and not copyrighted or owned by others.
- Participants must own the rights to the submitted photographs.

5. Fees

- The entry fee for the Contest is non-refundable.
- The fee is 3000/- per person, and include 3 photos for submission- 1 photo each category and maximum 3 categories allowed to submit.

6. Deadline

- The deadline for submission is 5th November.
- Late submissions will not be accepted.
- Participants are allowed to register themselves and allowed to submit the photos later if they are planned to submit the image on later stage.
- Participants are allowed to change their submission only once before the submission deadline.

7. Usage Rights

- By participating in the Contest, participants grant Shoot for Pleasure and its sponsors the right to use, reproduce, display, and distribute the submitted photographs for promotional, marketing, and other purposes without any further compensation or notification.
- Shoot for Pleasure reserves the right to use the photographs in future events, exhibitions, and publications.

8. Ownership and Copyright

- Participants retain the copyright to their submitted photographs.
- By participating in the Contest, participants warrant that their photographs do not infringe on the rights of any third party.

9. Judging Criteria

- The photographs will be judged on creativity, composition, technical skills, and relevance to the category.
- The decision of the jury will be final and binding.
- Judging and Criteria details will be announced separately.

10. Awards and Prizes

- The prizes and awards will be announced separately.
- Winners will be notified through email and phone.

11. Liability

- Shoot for Plesasure will not be liable for any loss or damage to the submitted photographs.
- Participants are responsible for ensuring that their submissions are free from viruses and other malware.
